PURPOSE: The City is procuring testing equipment in anticipation of the Electric 'post AMI' processes.

BACKGROUND: The Electric Department is seeking the ability to procure two Three-Phase Meter Site Analyzers. The metering division currently has two service vans, so one will accompany each service team. After AMI deployment, Electric will be performing QA/QC testing on installations and existing metering sites. These units are sole source because they interface with our existing test boards in our metering lab. These RW-30X units will meet our needs. The RW can perform a complete meter site analysis encompassing Power Quality, Meter Testing, and Transformer Testing without removing the meter. Capabilities including Waveform Capture, Harmonic Analysis, CT Testing, Vector Diagrams and Trend Recording, provide validation and peace of mind that the entire metering installation is correct.

BUDGET IMPACT: Funds are included in the Electric operating budget to cover this project.

RECOMMENDATION/ACTION REQUESTED: Staff are recommending that City Council approve, and the department be given the ability to procure these units via Sole Source. The department is recommending that the bid for this meter testing equipment be awarded to Radian Research, Inc. for \$102,653.20.
