Dear Owner/Tenant/Representative,

A site visit was made as requested by the City of High Point Emergency Communications to 2138 Surrett Drive, High Point, NC 27263 concerning a building collapse. It was discovered that the building is especially dangerous life due to the bad condition of walls, defective construction, decay, unsafe wiring, and other causes including collapse of the roof and catastrophic damage to the side wall of the building. As a result of our inspection, this structure has been cited as defective and in a hazardous condition pursuant to NC General Statute 160A-426 and condemnation placards have been affixed to the building.

You are hereby notified to take immediate corrective action to safeguard the site by repairing or demolishing the structure. Please respond within ten (10) days of receipt of this letter with an immediate timeline for repair or demolition. If no reply has been received after ten days of receipt of this letter, the City of High Point Inspections Department will schedule a condemnation hearing to determine the best course of action in the interest of public safety.
