A qualifying higher bid is one that: (i) is submitted by an individual or entity that is current on payment of all property taxes owed to the City and County, (ii) raises the existing offer to an amount not less than \$ 715.00 and (iii) is not conditioned on anything occurring prior to the purchase of the property.

A qualifying higher bid must be accompanied by a deposit in the amount of five percent (5%) of the bid; the deposit may be made in the form of a cashier's check or money order made payable to the City of High Point. The City will return the deposit on any bid not accepted, and will return the deposit on an offer subject to upset if a qualifying higher bid is received.

The buyer must pay cash at closing and will be responsible for all advertising costs incurred by the City during the upset bid process, which will be added to the purchase price at closing on the property.

The City Council must approve the final high offer before the sale is closed, which it will do within 30 days after the final upset bid period has passed.
