PURPOSE: City Council is asked to award a construction contract for the Oakwood Cemetery and Parking Lot Improvements Project to Blythe Construction, Inc. DBA Hanes Construction.

BACKGROUND: The city is resurfacing internal streets at Oakwood Cemetery and making improvements to various city parking lots at the following locations:

 - Construction of parking lot to expand parking adjacent to Truist Point Stadium, including sidewalk and landscape improvements along Appling Way, W. English Rd., and N. Lindsay St.
- Employee and Equipment Parking Lots at Municipal Operations Center (816 E. Green Drive)
 - Base repairs and resurfacing
- High Point Transit Bus Lot (716 W Martin Luther King Jr Drive)
 - Base repairs and resurfacing


Construction of the new parking lot at 208 N. Lindsay has a contract completion date of May 31, 2024. The overall contract time for the contract is 240 calendar days.
