#### PURPOSE:

On March 30, 2022, the City received bids for materials to perform maintenance to Jackson Lake Substation. Purchasing this equipment will allow the City to upgrade the existing substation and increase the electric system's capacity. Purchasing received 10 total bids for the schedules listed below.

# **BACKGROUND**:

The Electric Department is procuring materials to be used on the Jackson Lake Substation project (project is in the Electric CIP). The Purchasing Department solicited bids for Substation Structure, Circuit Switchers, 15 kV Breakers, Relay/Control Panels and Power Transformers to be used at our Jackson Lake Substation. These are all standard materials used regularly by the City of High Point Electric Utilities department.

### **BUDGET IMPACT:**

Funds are included in the FY 22 and FY 23 budget to cover this project.
