Subject: Strategic Update on Code Enforcement Activity for April 2022

This report summarizes Code Enforcement activity for the month of April. During this period Local Codes Enforcement (LCE) staff processed 16 new minimum housing complaints; 113 new public nuisance complaints and collected 225 signs. Additionally, during the month of April:

- LCE staff recorded 19 zoning complaints.
- A total of 57 Public Nuisance cases were abated (5 City abated and 52 owner abated).
- 2 inspectors worked on a Saturday morning in April (4/23) and collected 60 signs.
- 3 properties with ordinances passed are in the appeal period. Demolition bids will be requested when appeal period has expired.
- 7 properties have been bid out for demolition.
- There are 6 housing cases with an ordinance passed for demolition waiting for repairs to be completed (337 Wingo, 210 Underhill, 1004 Prospect, 524 Cross, 1113 Jefferson and 2206 Gable Way).
- One inspector position remains open.
- During the report period there were 500 total active cases:
 - o 253 active minimum housing cases
 - o 145 active public nuisance cases
 - o 102 active zoning cases
