PURPOSE:

The North Carolina Department of Transportation (NCDOT) is requesting concurrence from the City of High Point regarding a speed limit ordinance update for Weaver Avenue. This will ensure that the posted speed limit matches the most current ordinance for both the City and the NCDOT.

BACKGROUND:

This action will reduce the speed limit on Weaver Avenue to 25 mph posted. This speed limit reduction was requested by the residents through the NCDOT's petition process. The majority of the residents of this street live outside the High Point city limits. This reduction is appropriate to the nature of the street, which is residential and varies in width from 15 - 20 feet.

BUDGET IMPACT:

The proposed NCDOT ordinance update will not impact the City's budget and no further action is required by the City for implementation. Any additional signing will be provided and installed by NCDOT. Future sign repairs and replacements by City forces will be eligible for reimbursement by NCDOT under Schedule A of a Municipal Traffic Maintenance Agreement, as they are now.
