Subject: Request to purchase Mobile Air/Light Truck

I respectfully request that the following be included for consideration at the next city council meeting on April 21, 2014.

The Fire Departments Mobile Air Unit was purchased and built in 1990. This unit has served the Department and City well for 24 years. A proposal was made to your office and the city council for funding to replace this unit with an up to date modern Air/Light Unit. This request was granted and funded by city council in our 2013/2014 budget.

We have met with the Purchasing Director and her staff who are assisting us with this project. Purchasing advertised and requested an RFP from potential vendors. It has been decided that our most cost effective option is to purchase the truck chassis and body from Atlantic Emergency Solutions and purchase the air compressor system from a cooperative entity.

The mobile unit we are purchasing should serve us well for 20 plus years with proper maintenance.

The Fire Department is recommending Atlantic Emergency Solutions be awarded this contract.
