#### **Annual Funding Sources**

- The CDBG program provides funding to develop viable communities by:
  - providing decent housing,
  - -a suitable living environment, and
  - opportunities to expand economic opportunities, principally for low/mod persons.
- HOME provides to fund a wide range of activities that:
  - -build, buy, and/or rehabilitate affordable housing for rent, or
  - -homeownership, or
  - provide direct rental assistance to low-income people.



#### **Federal Budget Update**

- 2014 HUD Allocations:
  - CDBG 809,899 (Reduction of \$35,054 from prior year)
    - Housing repairs associated with the lead program reduced in the amount of \$20,670.
    - Delivery costs for CNDD reduced by \$7,373
    - CDBG Program Administration reduced by \$7,011
  - HOME \$356,000 (Increase of \$18,109 from prior year)
    - Program Administration increased by \$1,811
    - CHDO increased by \$16,298





- Program delivery primarily consists of personnel costs;
- CPTP provides occupational training and graduates perform rehab services;
- Housing development funds to be realized from program income received from Mobile St lease purchases; &
- Urgent Repair program plus \$65k from CPTP to be used for home repairs.



## Hartley Ridge Multi-family Housing

- LIHTC development
- Est. funding = \$10,545,525:
  - > LIHTC Equity \$6,680,525
  - > CHP (Section 108) \$1,350,000
  - > State Tax Credits \$924,660
  - ➤ RPP (NCHFA) \$685,000
  - ➤ Bank (Conventional loan) \$905,393
- 84 units of affordable multi-family rental housing (2 & 3 bedrooms);
- Rents from \$215 to \$565 based on # of bedrooms size & household income
- Site is located near the intersection of W. Hartley Drive and Ingleside Drive.
