PURPOSE:

• A public hearing has been set as the City Council considers a request to approve \$4,500 as High Point's portion of a city/county match for a State of NC Building Reuse Grant for Vault Enclosures.

BACKGROUND:

- Vault Enclosures is a leading manufacturer of high quality aluminum and high density polyethylene enclosures for manufacturers of tablets for commercial/industrial users.
- The company expects to expand at 1004 Old Thomasville Rd. in the Randolph County part of the City of High Point. The company proposes to create 40 full-time jobs. It also proposes to invest \$1,000,000 to purchase, renovate, and equip the facility.
- The company's corporate office is at 231 Plaza Lane, and Vault currently has a month-to-month lease at 308 Burton Ave. where it has done manufacturing for the last few months.
- On behalf of the company, Randolph County will be applying for a State of NC Building Reuse Grant in the amount of \$180,000. If the grant is approved, the company would buy/move to 1004 Old Thomasville Rd. (while retaining its Plaza Lane location for a sister company).
- The state grant requires a 5% local match, which would be \$9,000. Randolph County proposes that it and the City of High Point each pay half of the local match or \$4,500 for each local government.
- Randolph County's public hearing will be held at the same time as the City's public hearing. The county's legal notice for its public hearing references 15 new full-time jobs, which complies with state grant's minimum requirements. The company head in a telephone call on 12-17-2014 to City Attorney JoAnne Carlyle and Loren Hill confirmed that the company plans to create at least 40 jobs.

BUDGET IMPACT:

• Upon the company being awarded the grant, the City would provide \$4,500 to Randolph County, as the City's half of a local match. The source of those monies would be the City's Economic Development Incentive Fund, which is funded by general and electric revenues.

RECOMMENDATION / ACTION REQUESTED:

• The staff of the High Point Economic Development Corporation recommends that the City Council authorize \$4,500 as the City's share of the grant's local match.
