**RESOLUTION OF INTENT TO CONSIDER
STREET ABANDONMENT
(Case # SA15-01)**

WHEREAS, the City Council has been petitioned to abandon the following right-of-ways:

- a. An unimproved alley lying approximately 160 feet north of E. Green Drive, between Smith Street and Walnut Street.
- b. An unimproved alley lying approximately 155 feet north of E. Green Drive, between Cable Street and S. College Drive.

WHEREAS, G.S. 160A-299 requires the Council to first adopt a resolution declaring its intent to abandon the above right-of-way and calling a public hearing on the question;

NOW, THEREFORE BE IT RESOLVED, THAT THE COUNCIL declares its intent to consider the abandonment of the right-of-way above described and sets Monday, February 16, 2015, at 6:15 p.m. as the date for said public hearing before the Council in the Council Chamber of the Municipal Building in High Point.
