The City of High Point regularly retains a utility contractor to assist us with emergency repairs and maintenance items on our water and sewer systems. Council is asked to approve contract 2015-007 for Emergency Water and Sewer Repairs.

BACKGROUND:

On Wednesday, May 27, 2015 the City of High Point received and opened bids for Contract ENG-2015-007, Emergency Water and Sewer Repairs Contract (2015). We received one bid:

Breece Enterprises, Inc. \$ 937,480.00

The availability date of this contract is immediately upon execution of the contract documents. The completion date for the contract work is June 30, 2016.

The purpose of this contract is to perform emergency repairs and some regular maintenance on existing water and sewer mains in the City of High Point's system. Typical work performed under this contract includes, but is not necessarily limited to replacing and or repairing: water service lines, meter yokes, meter boxes, fire hydrants, water valves, water mains, sewer service lines and cleanouts, sewer manholes, inverts and castings, sanitary sewer mains, storm sewer lines. This contract also covers the installation of new water and sewer service lines.
