PURPOSE:

The Stormwater Division of Public Services is requesting the purchase of an additional truck mounted vacuum debris collector to be used for cleaning storm drains, gutters, etc. Using the National Joint Powers Alliance (NJPA) contract 060612-ODB a new ODB Model SCL800SM-25 was identified for Council approval.

BACKGROUND:

The Stormwater Division of Public Services has three of these trucks now and they are providing excellent service and reliability since their original purchase in 2007. The purchase of this truck will increase collection efficiencies and allow them to have one as a spare to use while service and repairs are being performed. The price of \$165,877.05 is for the truck, vacuum body installation, and delivery. Estimated delivery is 90-120 days.
