#### PURPOSE:

The Water & Sewer Division of Public Services is currently using a 2004 Freightliner with a sewer vacuum that is in need of replacement due to age and hours. Using a National Joint Powers Alliance (NJPA) contract a 2016 Freightliner with a Vacall Model AJV1015 sewer vacuum is being recommended for Council approval.

#### **BACKGROUND:**

The Water & Sewer Division is currently using a 2004 Freightliner with a Jet Vac body that has over 183,000 miles. This truck is used daily for opening clogged sewer lines and performing routine maintenance. The Vacall Model AJV1015 sewer vacuum is similar to the one they are currently using and will meet their needs. The price of \$331,910.55 is for the sewer vacuum truck and includes a \$37,500 trade in allowance for our 2004 Freightliner sewer vacuum. Estimated delivery is 180-240 days.
