#### **PURPOSE:**

The City budgeted for extension of the water system in conjunction with the construction of the Ralph Lauren Facility on Highway 66. Contract 58-062514 was issued for the water line system improvements. This deduct change order is needed to finalize the contract documents.

#### **BACKGROUND:**

The construction of the water system improvements was completed ahead of schedule. The contract was a unit price contract based on estimated quantities. After completion of the work, some of the estimates were high and the City is due back a credit. Where estimated quantities were low the contractor is due additional funds. After review of the under amounts and the over amounts, there is an overall credit back to the City for the contract. The deduct (credit) change order will finalize the contract price to close out the project and unencumber the funds.


