Congratulations! The Solid Waste Association of North America (SWANA) is pleased to inform you that you have met the requirements for Certification. You are now SWANA Certified as a **Integrated Solid Waste Management Systems Technical Associate**. SWANA Certification is a tremendous professional achievement, it places you amongst an elite group of solid waste professionals. This Certificate acknowledges that you have demonstrated your ability to meet the standards established by the SWANA Certification Board.

Your SWANA Certification number is **972266**. The term of your SWANA certification is for three (3) years and will expire on **06/05/2018**. Your exam score was **83%**.

During the next three years, you will be responsible for accumulating **30 Continuing Education Units (CEUs)** in order to be eligible for recertification. To receive SWANA CEU credits individuals must submit a CEU form. This form must be completed for each seminar, meeting, conference, etc. that you attend and sent into SWANA's Certification Department. As you turn in your CEU forms to SWANA's Certification Program during the three (3) year term, the CEUs will be maintained in SWANA's database system. Customized CEU Forms are available for chapter and national SWANA sponsored events. You should always make a copy of the completed form and keep the original for future reference.

SWANA has many opportunities to obtain your needed CEUs, both at the Chapter and National levels. Enclosed is a list of the continuing education products and services that SWANA has to offer. Look at our website at www.SWANA.org or call us at 1.800.GO.SWANA (467.9262) to order training packages or for our course schedule. Our SWANA Chapters also hold meetings and seminars that may offer CEUs. The list of Chapter Events is listed on our website under "Calendar". We have what you need to stay SWANA Certified!

At the end of your three-year term, you will need to recertify. To recertify, CEUs, application, and renewal fee must be met and may be requested *one (1) year prior* to **06/05/2018**. Recertification is not based solely on your demonstration of Continuing Education. Your job responsibilities will also be assessed to insure your continued eligibility for SWANA certification.
