PURPOSE:

Consideration of an Interlocal Agreement with the Piedmont Authority for Regional Transportation (PART) for the installation of an electric vehicle charging station.

BACKGROUND:

PART has offered to provide the City with an electric vehicle charging station funded by a grant received from the North Carolina Solar Center. Similar units have been installed at other locations in the region, for example, at the Piedmont Triad Regional Council offices in Kernersville.

The charging station will be installed by City forces at the Library, along the north boundary of the parking lot adjacent to Krispy Kreme. This location has been approved by Library staff, and will not impact the proposed enhancements at the Library.

A fee structure will be established that will allow the City to recover electric service costs plus a nominal amount per charge that can be applied for future network fees and post-warranty maintenance. Revenue collections and quarterly distributions to the City will be handled by the charging station manufacturer.

BUDGET IMPACT:

PART has provided the charging station to the City of High Point at no cost. Installation costs estimated at less than \$500. PART has agreed to pay network fees for the first three years of service (afterwards, the annual fee will be approximately \$350).

RECOMMENDATION / ACTION REQUESTED:

Council is requested to approved the Interlocal Agreement and authorize the appropriate city official to execute all necessary documents.

RESOLUTION APPROVING AN INTERLOCAL AGREEMENT TO ALLOW FOR AN EXTENSION OF WATER AND SEWER SERVICE TO PROPERTY OWNED BY PIEDMONT TRIAD AIRPORT AUTHORITY

WHEREAS, pursuant to the provisions of Section 160A-461 of the General Statutes of North Carolina, the City of High Point ("City") is authorized to enter into interlocal agreements with other units of local government and local political subdivisions in order to execute any undertaking; and

WHEREAS, Piedmont Authority for Regional Transportation ("PART") is a local political subdivision of the State, established under North Carolina General Statute Chapter 160A, Article 27 and became incorporated on the 17th day of July, 1998; and

WHEREAS, PART is the recipient of Clean Fuel Advanced Technology funds from the North Carolina Solar Center to purchase and have installed multiple plug-in electric vehicle ("PEV") charging stations in the Piedmont Triad; and

WHEREAS, the City has been identified as a recipient of one (1) level two PEV charging stations to be installed by the City in the City's urban core for the use of the residents of High Point and surrounding areas; and

THEREFORE, BE IT RESOLIVED that the High Point City Council hereby approves an Interlocal Agreement between the City and PART to allow for the installation of one PEV charging station to be funded by the Clean Fuel Advanced Technology award received by PART..
