RE: 2016 Contracted Street Resurfacing

The City of High Point performs Street Resurfacing on an annual basis. This resurfacing takes place because deficiencies on a section of roadway are beyond repair of normal routine maintenance. The list of roads to be resurfaced is generated from a pavement condition survey that assesses the cities needs.

The Public Services Department has selected the following list of roads based on the deficient pavement condition ratings:

- Old Mill Road from Johnson Street to Ashley Park Court
- Westover Drive from Hartley Drive to N. Main Street
- McGuinn Drive from University Avenue to Guyer Street
- Hamilton Street from Kearns Avenue to Johnson Street
- South Road from W. English Road to city limits
- N. Centennial Street from Eastchester Drive to Lakecrest Avenue
- Prospect Street from Dublin Avenue to R.R. tracks (near W. English Road)
