- 1. Hired two Code Enforcement Officers. Their initial training and focus will be on minimum housing code violations
 - o One started 4-4-16
 - o One started 4-18-16
- Contracted with State Code Enforcement Inc. (SCEI) to provide three Code Enforcement Officers beginning 4-18-16
 - o SCEI has been assigned to work on public nuisance violations
 - o During the first week (4-18-4-22):

- 309 signs were pulled from City right of way, medians poles etc...
- 91 public nuisance violations cited
- 3. We will continue to seek suitable replacements for Code Enforcement Officers and the Code Enforcement Manager
