PURPOSE:

The City of High Point wishes to place overhead utility lines underground along North Main Street from Ray to Parkway. This project will also include replacement of obsolete water and sewer mains existing in N. Main Street between Westwood and Parkway. Council is asked to approve contract 2016-007 for N. Main Street Utility Improvements.

BACKGROUND:

On Wednesday, June 29, 2016 the City of High Point received and opened bids for Contract ENG-2016-007. We received two responsive bids. A previous attempt to bid the work on June 1, 2016 resulted in a re-bid due to only one bidder responding:

Yates Construction Company, Inc. \$ 5,889,360.75 Sharpe Brothers \$10,094,573.85

The availability date of this contract is immediately upon execution of the contract documents. The completion date for all work contained in the contract is 400 calendar days from Notice to Proceed.

The purpose of this contract is to relocate existing overhead utility lines and place them underground along North Main Street between Ray and Parkway. As part of this project, overhead lines will also be placed underground along portions of Parkway, Montlieu, Sunset and Ray. During the course of this work we will also replace two existing obsolete water lines (16 inch and 8 inch) as well as an obsolete sanitary sewer line (some dating back to 1902), and repair any existing damaged storm sewer lines between Westwood and Parkway. Private utilities owned by North State Communications, Time Warner Cable and Piedmont Natural Gas are being replaced or relocated throughout the project limits. Upon completion of the underground utility work, the street will be milled and resurfaced to restore storm gutter capacity and provide a fresh riding surface. The traffic signal at N. Main and Montlieu/Sunset will be replaced with a mast-arm type signal. As allowed by NCGS, the City negotiated with the lowest responsive bidder to reduce the contract cost by \$311,900.00. Thus bringing the requested award amount to \$5,577,460.75.

Detour routes will be established for ALL northbound traffic during construction. Southbound traffic will be reduced to one lane through the active work zone area. Businesses will remain open during construction.
