PURPOSE:

• City Council will consider a request from Crown Mark to authorize up to \$181,000 in performance-based incentives for the company's expansion. The company would add \$11.7 million to the tax base and add 10 new jobs, with an average wage of \$50,000.

BACKGROUND:

- Crown Mark was started in 1983. The company specializes in residential furniture and accessories for bedrooms, dining rooms, living rooms, and home offices.
- The company currently has 37 employees at its two High Point locations a showroom at 204 East Green Street and a 100,000-square foot distribution facility that it leases at 4193 Eagle Hill Drive.
 - o The company's corporate offices are in Houston, Texas, where it also has a distribution center.
 - o The company's third distribution center is in Pomona, California.
- The company is considering purchasing land at 720 Gallimore Dairy Road and constructing a 250,000-sq. ft. distribution center, which it would own. The company could also construct an additional 100,000-square feet of flex space on the property in a second phase (the amount of the proposed incentive does not reflect the Phase 2 possibility).
- The High Point Planning & Zoning Commission is considering the annexation and zoning of this property on September 27, 2016 and those cases could then come before the City Council on November 7, 2016.
- High Point and an out-of-state location are under consideration for this project.

BUDGET IMPACT:

• If the company meets all of the benchmarks outlined in a performance agreement, it could receive up to \$181,000 in installment payments over a three-year period. The source of that funding would be the City's Economic Development Incentive Fund, which is funded by general and electric revenues.

RECOMMENDATION / ACTION REQUESTED:

- The High Point EDC staff recommends that the City Council authorize up to \$181,000 in performance-based incentives for the Crown Mark expansion project at 720 Gallimore Dairy Road.
- The City Council authorizes the City Manager to execute a performance agreement with the company, containing benchmarks for the company to achieve and a schedule for the payment of such financial assistance.

Pursuant to N.C. The City would be authorized to provide this financial assistance upon the company's construction of a new building and job creation – pursuant to an incentive performance agreement containing benchmarks and schedule for the payment of such financial assistance.
