PURPOSE:

The Police Department will be in the process of hiring eight additional officers during this budget year and vehicles will be needed once the training is complete. Using NC State Contract 070B Item # 13, the 2017 Dodge Charger has been identified for City Council approval.

BACKGROUND:

The Police Department has been using the Dodge Charger for several years and it meets their needs. The price of \$26,979 includes the vehicle and equipment package. Total cost for eight is \$215,832. Estimated delivery is 90-120 days.
