#### PURPOSE:

The Parks and Recreation Department seeks to finalize a grant application with the Connect NC Bond Grant Program. The application requires City Council endorsement and execution by the Mayor. The proposed project encompasses improvements and additions at both Oak Hollow Marina and Sailboat Point. These improvements include: a new, accessible dock and internal connecting sidewalks at Sailboat Point, poured in place rubber surfacing for playground at the Marina, wheelchair accessible swings, internal connecting sidewalks at the Marina as well as a dock that provides handicap access for kayaks and canoes.

# **BACKGROUND**:

The Connect NC Bond package was approved in March 2016 and included one time funding of \$3 million for local Parks and Recreation Departments. This program is specific to projects that build special facilities or adapt existing facilities that meet the unique needs of children and/or veterans with physical and developmental disabilities.

#### **BUDGET IMPACT:**

The total cost for the project is \$259,125. This is a 4 to 1 grant and if awarded, the city's responsibility will be \$64,781 and this will be included in the 2017-2018 Annual Budget.

# **RECOMMENDATION / ACTION REQUESTED:**

The Parks and Recreation Department recommends Council endorse the application and authorize the Mayor execute application with the Connect Bond Grant Program.
