A temporary construction easement consisting of approximately 1,296 square feet as shown on the attached exhibit map is required on the City of High Point's property located at 1841 Eastchester Drive, county tax parcel # 0200170 and on the west side of the Festival Park entrance. As part of the interchange widening project, the curb and gutter will be upgraded extending to this property. The easement does not encroach into the driveway entrance. 
SUBJECT: Dedication of a Temporary Construction Easement to NCDOT


