PURPOSE:

In accordance with State law, the City Council must conduct a public hearing to receive comments with regards to City Council's consideration of an installment financing contract through the issuance of limited obligation bonds to pay for the Downtown Multi-Use Sports and Entertainment Facility.

BACKGROUND:

The issuance of any debt obligation (bonds, notes, financing agreements, and leases) of the City requires the authorization of the City Council. The issuance of an installment financing contract, in this case through limited obligation bonds, is authorized by G.S. 160A-20.

The statute requires approval of the Local Government Commission because the proposed transaction will be collateralized by real property. As required for that body's approval, a public hearing on the proposed financing must be conducted by the City Council.

WHEREAS, the City Council (the "City Council") of the City of High Point, North Carolina (the "City") is considering the financing of the acquisition, construction and equipping of a downtown multi-use sports and entertainment facility and related appurtenances (the "Project"), all pursuant to an installment financing arrangement;

WHEREAS, in order to finance the Project, the City proposes to enter into a trust agreement or similar financing agreement (the "Agreement");

WHEREAS, as security for its obligations under the Agreement, the City proposes to execute and deliver a deed of trust granting a lien on the site of the Project, together with all improvements and fixtures located or to be located thereon;

WHEREAS, in accordance with Section 160A-20(g) of the North Carolina General Statutes, the City is required to hold a public hearing on the proposed Agreement described above; and
