At its December 14, 2017 meeting, the Board of Adjustment unanimously approved a recommendation to the City Council, asking the Council to recommend that the Guilford County Board of Commissioners remove Sandra Dunn as the Board's regular Extraterritorial Jurisdiction (ETJ) member and replace her with Tyler Walsh, who is currently one of the Board's alternate members. The BOA recommendation included appointing Sandra Dunn as the Board's alternate ETJ member.

Ms. Dunn, who does not live in the City's ETJ, was appointed by the County Commissioners in October 2016 as the Board's regular ETJ member, after several attempts by both the City and the County to find someone residing in the ETJ to serve, failed.

In making this recommendation, the BOA noted that due to a light schedule, there were only three meetings in 2017, two of which Ms. Dunn did not attend. The members agreed that it would be better if Ms. Dunn was an alternate ETJ member, which would allow her to learn and gain experience as her availability permits.

Mr. Walsh, who also does not live in the City's ETJ, has been on the Board as an alternate member for well over two years.

It is the City Council's decision whether to support the recommendation of the BOA and forward its request to the County Commissioners. If Council does not forward the request, the matter is closed. If forwarded, the Commissioners will decide whether to make the changes requested.
