THIS AGREEMENT is made and entered into on the last date executed below, by and between the North Carolina Department of Transportation, an agency of the State of North Carolina, hereinafter referred to as the "Department", and the City of High Point, hereinafter referred to as the "Municipality."

WITNESSETH:

WHEREAS, the Department and the Municipality on 10/21/2014, entered into a certain Project Agreement for the original scope: providing pedestrian access, crossing improvements and sidewalk improvements to serve Oak Hill Elementary, Fairview Elementary, Johnson Street Global Studies, Triangle Lake Montessori and Shadybrook Elementary schools, programmed under Project SR-5001CE; and,

WHEREAS, the parties have agreed to increase the funding for the Project;

NOW THEREFORE, the parties wish to supplement the aforementioned Agreement whereby the following provisions are amended:

FUNDING

The Department agrees to reimburse the Municipality an additional \$560,000 (80%) of Transportation Alternatives Program funds. The Municipality will provide \$140,000 as their 20% local match.

Except as hereinabove provided, the Agreement heretofore executed by the Department and the Municipality on 10/21/2014, is ratified and affirmed as therein provided.
