STRATEGIC PLAN UPDATE**2018-182 Council will receive an update on the Strategic Plan from Council**

Council Member Jeff Golden, Chair of the Community Housing, Neighborhood Development and Public Safety Committee and Council Member Jason Ewing, Chair of the Prosperity & Livability Committee.

Code Enforcement/Blight

Community Housing, Neighborhood Development & Public Safety Committee Chair Council Member Golden provided an update on some numbers as they relate to the Code Enforcement efforts regarding blight in the city. He then shared numbers for the May 2018 activities as follows:

- ✓ 26 New Minimum Housing Complaints
- ✓ 278 Active Minimum Housing Cases
- ✓ 286 New Public Nuisance Complaints
- ✓ 329 Active Public Nuisance cases
- ✓ 70 Signs collected

Lori Loosemore, Local Codes Enforcement Supervisor, added that two candidates have been selected to fill the vacant Local Codes Enforcement Officer (LCE) positions. The two new officers will begin work on June 11th. she then shared some photographs of some on-going Code Enforcement activities for the month of May 2018.

Connect HP

Prosperity & Livability Chairman Jason Ewing reported that Connect HP has met a few times and they now have a new Chairman, Taz Ameen. He reported on the "Meet & Greet" event with the Master Developer for the Catalyst Project, that was recently held at the High Point Theatre. He noted that Master Developer Tim Elliot was not able to attend, but City Manager Greg Demko and Ray Gibbs, Executive Director, Forward High Point did the presentation. He then turned the floor over to City Manager Demko for an overview of the event.

Mr. Demko advised that a PowerPoint was presented with a narrative of the development planned around the stadium and they also shared a model of the downtown development, which picqued a lot of interest. He felt the walkability of N. Elm Street and Church Street would be a real positive move.

Mayor Pro Tem Williams asked about the possibility of a presentation to the City Council by the new chairman, Taz Ameen of Connect HP. Council Member Ewing agreed to set it up.

Public Comment Period

A Public Comment Period will be held on the first Monday of the regular City Council meeting schedule at 5:30 p.m. or as soon thereafter as reasonably possible following recognitions, awards and presentations. Our policy states persons may speak on any item not on the agenda.

- Persons who have signed the register to speak shall be taken in the order in which they are listed. Others who wish to speak and have not signed in will be taken after those who have registered.
- Persons addressing City Council are asked to limit their comments to 3 minutes.
- Citizens will be asked to come to the podium, state their name and address and the subject(s) on which they will comment.
- If a large number of people are present to register concerns about the same subject, it is suggested that they might be acknowledged as a unified group while a designated speaker covers the various points. This helps to avoid repetition while giving an opportunity for people present with the same concerns to be recognized.

Thanks to everyone in the audience for respecting the meeting by refraining from speaking from the audience, applauding speakers, or other actions that distract the meeting.

Jason Oliver Nixon, a resident at 1121 North Rotary Drive, addressed Council regarding the on-going speeding issues on North Rotary Drive. He advised that they have started a group, Slow Down North Rotary in an effort to help combat the speeding problem. He submitted a petition that contained 36 names of residents who live on North Rotary or whose property abuts North Rotary and they expect additional names will be added. [The petition will be attached in Legistar as a permanent part of these proceedings].

Mr. Nixon implored Council to take some action to remedy the situation and encouraged them to create a walkable, safe neighborhood for the residents that are already in High Point and for those who would be moving to High Point as the city continues to evolve.

***Joe Guzman**, who resides at 118 Bridlewood Avenue in High Point, questioned the sewer fees that the city charges for filling up pools. He advised in the past, he had received a sewer waiver for filling up his pool, but that was not the case recently. Council Member Jones noted in the past that the city offered discounted sewage rates for topping off or adding water to pools and suggested that Mr. Guzman may want to look into that. Mayor Wagner recommended Mr. Guzman get with Deputy City Manager Randy McCaslin to discuss his concerns further.*

***Louis Thibodeaux**, a resident at 1242 Kensington Drive in High Point, mentioned the recent "Meet & Greet" with the Master Developer for the downtown Catalyst Project that was held at the High Point Theatre. He asked about the possibility of putting the model that was displayed showing the buildings/development for the project at the Library so other citizens can see it. Assistant City Manager Randy Hemann advised that plans are already underway to display it at the Library.*

There being no one else to speak, the Mayor closed the Public Comment Period.

2018-185 Agreement - Cooper Consulting Company - Rewrite of Sign Regulations

2018-186 City of High Point 2018-2019 Budget Ordinance and Related Documents

City Council is requested to adopt the FY 2018-2019 Budget Ordinance for the City of High Point and associated fee schedules.

Eric Olmedo, Budget & Administrative Director, explained this is a culmination of eight months of work and meetings that will be held. He thanked staff and Council for their assistance in the process. He introduced Laura Altizer and Roslyn McNeill with the Budget Office who were instrumental in putting the budget together. Also included as part of the budget is the Comprehensive Fee Schedule which incorporates the proposed changes that have been discussed in regards to development fees and water/sewer fees. Although the FY 2018-2019 Budget will be effective July 1, the proposed changes to the development fees and water/sewer fees will go into effect on October 1, 2018.

Mr. Olmedo shared the good news that an additional \$78,452 was received for the 911 grant funds, which has also been incorporated into the FY 2018-2019 Budget Ordinance.

Council Member Ewing inquired about the High Point Convention & Visitors Bureau's budget. Mr. Olmedo replied that the CVB budget is scheduled for approval on June 18th.

PENDING ITEMS**2018-169 Amendment to License Agreement - Cingular Wireless PSC, LLC (AT&T)**

City Council is requested to approve an Amendment to the License Agreement with Cingular Wireless PCS, LLC (AT&T) which allows the location of communication equipment at the City's Ward Water Plant; and authorize the City Manager to execute the agreement.

Note: This matter was initially heard by the City Council at the May 21, 2018 Meeting and action was taken at that time to refer the matter to the Finance Committee for further discussion.

2018-100 High Point Area Arts Council Assistance Agreement

City Council is requested to approve an Agreement providing assistance from the City of High Point of up to \$181,324.00 over the next two fiscal years for the satisfaction of a \$362,648 mortgage associated with the High Point Area Arts Council purchase of property located at 121 S. Centennial Street.

Note: This matter was initially heard by Council on April 2, 2018, at which time it was tabled and sent to the Finance Committee for further discussion. It was discussed by the Finance Committee on May 3, 2018 and forwarded back to the City Council with no recommendation. It was again discussed at the May 7, 2018 City Council Meeting. At the May 7, 2018 meeting, a series of motions were made including denial of the Arts Council Agreement, which did not pass. The prevailing motion was to refer it to the Prosperity & Livability Committee for further discussion. The matter was again discussed by the Prosperity & Livability Committee on May 9, 2018 and after another lengthy discussion, no recommendation was made. However, the Committee agreed to discuss it further at their June 6th meeting. The Prosperity & Livability Committee met and discussed this request again at their June 6, 2018 meeting. At this meeting, a motion was made to approve a matching grant up to \$90,000 for next year; however, the motion resulted in a 2-2 tie vote of the Committee. Due to scheduling conflicts with the Committee, it was agreed that this matter would be placed on the August 6, 2018 High Point City Council Agenda.

2018-187 Public Hearing - Community Development and Housing Department 2018-2019 Annual Action Plan

Monday, June 4, 2018, is the date and time set for a public hearing on the approval of the Community Development and Housing Department 2018-2019 Annual Action Plan. The plan was approved by the Citizens Advisory Council at their meeting on Thursday, May 24, 2018 and has been available for public review for 30 days.

Mike McNair, Director of Community Development & Housing, provided a summary and overview of the 2018-2019 Annual Action Plan outlining the activities that will be undertaken. He explained that staff had originally planned to bring the Annual Action Plan to Council the first meeting in May, but because of the late passage of the Omnibus package, they decided it would be better to await receipt of the final numbers.

The 2018-2019 Action Plan continues on-going activities such as Operation Inasmuch and also includes continuation of core city redevelopment activities. As far as funding sources, the budget is comprised of about \$3.87 million with most of those being federal dollars. Mr. McNair pointed out much of the income for the HOME program comes from the sale of houses. It continues a commitment to affordable housing and highlights the newest proposed affordable housing project, Avondale Trace Apartments, which will be located off Wendover

Avenue. Currently there are 30+ houses in Habitat Village in the Washington Terrace area and 15 homes in the Southside neighborhood.

Chairman Golden asked staff to elaborate on the Cedrow affordable housing. Mr. McNair explained that this is a project which is a partnership with Pinnacle Bank. The city has acquired property on Cedrow consisting of about 4 acres. The city's participation is to put in the infrastructure with Pinnacle doing the construction and the mortgage.

Regarding the Community Capacity Building, Mr. McNair reported that the Citizens Advisory Council (CAC) puts a lot of effort on public service grants. This year, 16 applications totaling \$123,000 were received; the CAC funded 9 of the applications totaling \$61,050.

Following Mr. McNair's presentation, Chairman Golden opened the public hearing and asked if there was anyone present who would like to speak regarding the proposed 2018-2019 Annual Action Plan. There being no one present to comment, the public hearing was closed.

Approved the 2018-2019 Annual Action Plan and authorized the appropriate City official and/or employee to execute all necessary documents.

City Council is requested to adopt an ordinance ordering the housing inspector to effectuate the demolition of a dwelling located at 519 Roy Avenue belonging to Tom F. Gould.

Lori Loosemore, Local Codes Enforcement Supervisor, advised this structure was first inspected on May 23, 2017. A hearing was held on June 6, 2017 and no one appeared for the hearing. It was determined at that time that the property repairs exceeded 65% of the value of the structure and an Order to Repair or Demolish was issued on June 6, 2017 with a compliance date of July 6, 2017. The property owner, Mr. Gould, did contact the inspector on May 26, 2017 and advised that the property was in bankruptcy and he no longer owned the property and could not attend the hearing. Property taxes are delinquent in the amount of \$3,807.00.

There was no one present to speak regarding this housing case.

2018-189 Ordinance to Demolish - 514 Prospect Street

City Council is requested to adopt an ordinance ordering the housing inspector to effectuate the demolition of a dwelling located at 514 Prospect Street belonging to Willie Juanita Cecil (deceased).

Lori Loosemore, Local Codes Enforcement Supervisor, advised an original inspection of this property was conducted on July 21, 2017 and a hearing was held on December 12, 2017. She explained that because they found out the owner was deceased, to ensure proper service of notification to the property owner, they had to advertise in the newspaper for compliance to meet the notification requirement per the statute. No one appeared for the hearing that was held on December 12, 2017 and an Order to Repair or Demolish was issued with a compliance date of January 17, 2018. To date, staff has not heard from the property owner or anyone in regards to the property and it is pending foreclosure with the Guilford County Tax Department with \$8,218 in delinquent taxes being owed on the property.

2018-190 Ordinance to Demolish - 309 Kennedy Avenue

Lori Loosemore, Local Codes Enforcement Supervisor, advised this property was originally inspected on November 29, 2017 and no one appeared for the hearing that was held on November 29, 2017. At that time it was determined that the repairs exceeded 65% of the value of property which prompted the issuance of an Order to Repair or Demolish on February 7, 2018 with a compliance date of March 8, 2018. The inspector did speak with the owner prior to the hearing and he advised that a fire had occurred upstairs that caused significant damage, but the property owner was unaware of the fire damage. The property is pending foreclosure with the Guilford County Tax Department and is past due taxes in the amount of \$10,572 are owed on the property.
