PURPOSE: The City of High Point disposes bio-solids from the wastewater system via incineration. The work for this project included installation of two new centrifuges, two new cake pumps, and rehabilitation of the incinerator to comply with new EPA air emission requirements.

The City prepurchased the centrifuges, cake pumps, and incinerator under separate bids. This project installed all the new equipment and any additional required equipment to make the new solids handling system operational.

BACKGROUND: This change order is for additional repairs and replacement of mercury control equipment identified during the project.

BUDGET IMPACT: Funds for this change order are available in the adopted budget.

RECOMMENDATION / ACTION REQUESTED: Public Services is recommending that Council approve Change Order 7 to Wharton - Smith, Inc. for \$1,216,000.

See the work items identified in Contractor's July 25, 2018 letter and the labor rates set forth in Contractor's June 8, 2018 letter (copies of which are attached to this Change Order). Contractor's compensation for the performance of these work items will be on a time and materials basis, with labor being charged at the rates set forth in Contractor's June 8, 2018 letter and materials and other costs being charged at Contractor's costs plus a 15% markup. Contractor's current non-binding estimate of Contractor's total charge for the performance of these work items is \$1,216,000. If during performance of this work Contractor anticipates that the total charge for a work item will be greater than 110% of the Estimated Budget for that item set forth in Contractor's July 25, 2018 letter, Contractor will notify Owner and Engineer immediately and will provide an updated Estimated Budget for that work item to Owner and Engineer. Substantial completion of the work items covered by this Change Order will be achieved by November 1, 2018, and Final Completion of the work items covered by this Change Order will be achieved by December 31, 2018. Notwithstanding anything in the contract documents or this change order to the contrary Wharton-Smith, Inc. reserves and retains its rights to seek additional contract time resulting from the additional work granted by this change order.

In accordance with the General Conditions of the Contract Documents, you are hereby requested to submit a <u>cost</u> along with detailed breakdowns to <u>perform</u> the following work.

- 1. Contractor shall remove the existing GAC Absorber and associated equipment and shall store in a location as directed by the Owner. The following will be required:
 - a. All ducts and piping shall be disconnected from the GAC Absorber. Ducts and piping to remain shall be temporarily supported and sealed.
 - b. All electrical conduit shall be safely disconnected, temporarily supported, and appropriately sealed.
- 2. All work shall be performed on a time and materials basis. The Contractor shall submit as part of this RFP proposal their current unit rates for labor, equipment, project management, etc., required to perform construction work. These rates will be the basis for future work to be completed. Adequate records shall be kept properly documenting time and materials costs.
