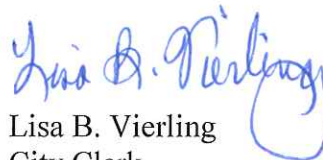
Dear Mr. Fitzwater:

Created pursuant to Title 9, Chapter 9, Section 9-9-5 of the Code of Ordinances. Length of Term/Years: 3 years Ward specific taking into consideration Historic District requirements for representation as contained in Section 9-9-5(b)(2) of the Development Ordinance the the following criteria for appointments: 1) all members must reside within the territorial jurisdiction of the unit of government that is the CLG; 2) all members must have a demonstrated interest, competence, or knowledge in historic preservation; 3) the CLG must document in writing its good faith effort to appoint professionals from the disciplines of architecture, history, architectural history, planning, archaeology, or other related disciplines, to the extent such professionals are available in the community and willing to serve; and 4) the CLG must fill the commission vacancies within sixty (60) days after the vacancies occur.
