### **PURPOSE**:

A request by Guilford Technical Community College to abandon that portion of Clay Avenue lying west of S. Centennial Street.

### PLANNING AND ZONING COMMISSION RECOMMENDATION

### **Guilford Technical Community College**

**Street Abandonment 19-01** 

At its February 26, 2019 public hearing, the Planning and Zoning Commission reviewed Street Abandonment 19-01. All members of the Commission were present except for Mr. John McKenzie and Mr. Mark Walsh. Mr. Herbert Shannon, Senior Planner, presented the case and recommended approval of the request as outlined in the staff report.

### Speaking on the request:

Speaking in favor of the request was Mr. Mitchell Johnson, representative for Guilford Technical Community College, 601 East Main Street, Jamestown. Mr. Johnson stated that GTCC has purchased the parcels abutting the Clay Avenue right-of-way as part of a long-term master plan to expand their facilities from S. Hamilton Street to S. Centennial Street. The intent is to improve this area and create a pedestrian network that connects the various parts of the campus to the adjacent community.

# **Planning & Zoning Commission Action**

The Commission recommended *approval* of Street Abandonment 19-01, as recommended by staff, by a vote of 7-0.

### **Analysis**

Guilford Technical Community College (GTCC) is requesting to abandon that portion of the Clay Avenue ROW lying west of S. Centennial Street. This segment of the Clay Avenue ROW, formerly known as Davis Street, has a width of 40 feet, a length of 355 feet (14,209± square feet) and is partially improved with a 20-foot wide ribbon paved street. It was recorded in 1890 on a map entitled "High Point Development Company " in Plat Book 53 – Page 561 in the Guilford County Register of Deeds Office.

This street historically served several single family and multifamily dwellings along Clay Avenue. The last of these structures was raised in the mid-2000s and the abutting parcels have been purchased by GTCC. The college proposes to establish a paved walking trail from its campus, along S. Main Street, to the Macedonia Park and residential neighborhoods lying east of S. Centennial Street. Since the abutting parcels are all owned by GTCC, the abandonment of the City's interest in this ROW will not deprive any owner of access to their property.

The Technical Review Committee (TRC) reviewed this request and identified no concerns related to the abandonment of this ROW. The Public Services Department has identified a City water and sewer line running the length of this ROW and Piedmont Natural Gas has identified a gas line in this ROW. Thus, easements will need to be reserved over these existing utility lines.

# **Findings & Recommendation**

This abandonment of the public's interest and conveyance of the right-of-way to the abutting property owner, as provided by State statutes, is found not to be contrary to the public's interest. This proposed ROW abandonment will not deprive any property owners in the vicinity of this request reasonable means of ingress and egress to their property.

The Planning and Development Department recommends approval of the requested street abandonment with the retention of the following easements:

- A 20-foot wide sanitary sewer easement centered over all existing sewer lines within and crossing the Clay Avenue right-of-way;
- A 20-foot wide water easement centered over all existing water lines within and crossing the Clay Avenue right-of-way; and
- A 20-foot wide Piedmont Natural Gas easement centered over all existing gas lines within and crossing the Clay Avenue right-of-way.







Looking eastward along Clay Avenue, from Railroad ROW to S. Centennial Street



# **Street Abandonment (Closure)** Case 19-01

(abandon all the Clay Avenue right-of-way lying west of S. Centennial Street)

WHEREAS,

Guilford Technical Community College has petitioned the City Council of the City of High Point to permanently abandon (close) all of the Clay Avenue right-of-way lying west of S. Centennial Street. Clay Avenue is a 40-foot wide improved public street lying along the west side S. Centennial Street, approximately 85 feet south of Macedonia Way. This right-of-way, formerly known as Davis Street, was recorded in Plat Book 53 – Page 561 of the Guilford County Register of Deeds Office and is more specifically described as follows.

BEGINNING AT AN EXISTING 3/8" INCH IRON PIPE AT THE NORTHWEST INTERSECTION OF CLAY STREET AND S. CENTENNIAL STREET ALSO BEING THE SOUTHEAST CORNER OF THE TRUSTEES OF GUILFORD COLLEGE TECHNICAL COMMUNITY COLLEGE AS DESCRIBED IN DEED BOOK 7912 PAGE 1170, THENCE CROSSING THE EASTERN 40 FOOT WIDE RIGHT OF WAY AT IT'S EASTERN TERMINOUS AND ALONG THE WESTERN 50 FOOT WIDE RIGHT OF WAY FOR S. CENTENNIAL STREET S 03 DEG. 21 MIN. 03 SEC. W

DISTANCE BEING 40.00 FEET TO AN EXISTING 3/4 INCH IRON PIPE AT THE SOUTHWEST CORNER OF CLAY STREET AND S. E DISTANCE BEING 170.51 FEET TO AN EXISTING 3/8 INCH IRON PIPE, THENCE CONTINUING WITH THE NORTHERN 40 FOOT WIDE RIGHT OF WAY FOR CLAY STREET AND THE SOUTHERN LINE OF TRUSTEES OF GUILFORD COLLEGE TECHNICAL COMMUNITY COLLGE AS DESCRIBED IN DEED BOOK 7912 PAGE 1170 S 86 DEG. 42 MIN. 44 SEC. E DISTANCE BEING 145.02 FEET TO THE POINT AND PLACE OF BEGINNING CONTAINING 13,999 SOUARE FEET OR 0.321 ACRES MORE OR LESS.

WHEREAS, the petition has been duly filed with this Council in a Regular meeting assembled on the 18<sup>th</sup> day of February, 2019, at 5:30 p.m. setting the 18<sup>th</sup> day of March, 2019 at 5:30 p.m., in the Council Chambers of the Municipal Building, as the time and place for a public hearing before said Council on

said petition, and public notice of said time and place was ordered given, all pursuant to North Carolina G.S. 160A-299; and

WHEREAS, due and proper notice of said hearing to be heard on the petition at this meeting of City Council was made by publication in the High Point Enterprise for four (4) consecutive weeks, beginning February 22, 2019 and March 1, 8 & 15, 2019; and,

WHEREAS, the above entitled matter, pursuant to said resolution and notice was called for hearing before said Council at which time there was no objection or opposition offered on the part of any firm or corporation to abandon (closure) of the above described portion of Clay Avenue; and

WHEREAS, it appearing to the satisfaction of this Council and the Council finds as a fact that the said right-of-way as herein described is not necessary for ingress and egress to any land adjoining said street; that the closing of said street is not contrary to the public interest and that no other individual, firm or corporation owning property in the vicinity of said street, or in the subdivision in which said street is located, will be deprived of reasonable means of ingress or egress to this property.

## NOW THEREFORE BE IT RESOLVED:

- 1. That all of the Clay Avenue right-of-way, as described above, be closed pursuant to North Carolina G.S. 160A-299;
- 2. That the City of High Point shall retain a 20-foot wide water easement centered over all existing water lines within and crossing the Clay Avenue right-of-way;
- 3. That the City of High Point shall retain a 20-foot wide sanitary sewer easement centered over all existing sewer lines within and crossing the Clay Avenue right-of-way;
- 4. That athe City of High Point shall retain 20-foot wide Piedmont Natural Gas easement centered over all existing gas lines within and crossing the Clay Avenue right-of-way; and
- 5. That a copy of this resolution be filed in the Office of the Register of Deeds for Guilford County, North Carolina.
