PURPOSE:

To utilize GEA Westfalia to perform the manufacturer's 8,000-hour service rebuild on the two centrifuges at the Eastside Wastewater Treatment Plant.

BACKGROUND:

The two centrifuges at the Eastside Wastewater Treatment Plant (WWTP) are used for de-watering solids as part of the wastewater treatment process. The dewatered solids are then burned in the incinerator. The centrifuges were installed as part of the upgrade to the residuals management facility in 2016. The operation and maintenance manuals require the centrifuges to be rebuilt on a 3-year cycle. The rebuild includes disassembling each unit and replacing gaskets, seals, bearings, drive belts, and any additional maintenance requirements.

BUDGET IMPACT:

Funding is available in the 2018-2019 Budget.

RECOMMENDATION / ACTION REQUESTED:

Public Services is recommending that GEA Westfalia be approved as a sole source vendor to rebuild the centrifuges at the Eastside WWTP for the amount of \$89,958.95.
