PURPOSE:

The City intends to apply for a Hazard Mitigation grant through the North Carolina Division of Emergency Management (NCEM). NCEM requires that City Council adopt a resolution to designate primary and secondary agents for the purpose of applying for this grant.

BACKGROUND:

The City of High Point's Emergency Manager intends to apply for grants to add generators at the Allen Jay and Deep River Recreation Centers. The Federal portion of the grant will pay for 75% and the State will pay for 25% of the cost. If approved, there will be a future budget amendment to approve receiving the grant funds.

BUDGET IMPACT:

None. If approved the grant will pay 100% of the costs on a reimbursable basis.

City Council is requested to approve a resolution to designate Perry Hall, Emergency Manager and Brian Evans, Deputy Fire Chief with the Fire Department as the City's agents to apply for the NCEM Hazard Mitigation grant.
