2019-128 PUBLIC COMMENT PERIOD

A Public Comment Period will be held on the first Monday of the regular City Council meeting schedule at 5:30 p.m. or as soon thereafter as reasonably possible following recognitions, awards and presentations. Our policy states persons may speak on any item not on the agenda.

- Persons who have signed the register to speak shall be taken in the order in which they are listed. Others who wish to speak and have not signed in will be taken after those who have registered.
- Persons addressing City Council are asked to limit their comments to 3 minutes.
- Citizens will be asked to come to the podium, state their name and address and the subject(s) on which they will comment.
- If a large number of people are present to register concerns about the same subject, it is suggested that they might be acknowledged as a unified group while a designated speaker covers the various points. This helps to avoid repetition while giving an opportunity for people present with the same concerns to be recognized.

Thanks to everyone in the audience for respecting the meeting by refraining from speaking from the audience, applauding speakers, or other actions that distract the meeting.

Mayor Wagner opened up the floor for the Public Comment Period.

Chris McGhee addressed Council regarding concerns with pedestrian traffic and pedestrian crosswalks, specifically those that do not align with intersections that are not marked very well. He noted the crosswalks that are most used are located from the IHFC over to Furniture Plaza and there have been several close misses with pedestrians being almost hit by vehicles. He suggested painting YIELD across both lanes in both directions.

Larry Diggs, a resident at 1127 Biltmore Avenue, expressed concerns regarding the schools in High Point and asked if there was a way to influence the Guilford County School Board to help with the lack of resources in the High Point schools. He felt the schools in High Point are suffering since redistricting.

Mayor Wagner asked if there was anyone else present who would like to speak during the Public Comment Period. There being no further comments, the Public Comment Period was declared closed.

2019-125 Operating Agreement -Samet Corp. - Stadium Change Order #1

City Council is requested to approve Change Order #1 increasing the Guaranteed Maximum Price for the Stadium in the amount of \$1,573,703.

Mayor Pro Tem Ewing asked Assistant City Manager Randy Hemann to present the information that was presented during the Finance Committee regarding the Change Order on the stadium.

Transcript

Assistant City Manager Randy Hemann: Mayor and Council Members, I'd love to take just a second. It's not very often that I come to you and talk about it being a pleasure to increase the budget in an area, but this is one instance where that's true. If you look around the state right now, you'll see other stadiums being built. At least one that I'm thinking of that started off at \$33 million. It's now at \$40 million. I want to make it crystal clear that what you have in front of you tonight, you are still spending \$36.1 million for a stadium. Samet has done an incredible job of not just keeping the budget where it's supposed to be, but actually carving out savings. If you look at the 3rd floor deck that's above the Stadium Club, that's close to \$500,000 of steel up there that was actually carved out of the existing budget through savings in other areas. So, what you have in front of you today, while it does raise the amount of the budget for the stadium, that comes from an outside source. So, the Downtown Transformation Board, as well as the Team are actually funding these additional improvements to amount to a little more than \$1.5 million. There's about \$1,013,000.00 of that coming from the Downtown Transformation Board and around \$560,000 coming from the Team. Those cover scoreboard enhancements, center field gate enhancements modifying a sight wall, drink rails and suites, upgrades to suites, a scoreboard topper, the Heritage Lounge upfit which will have barn wood from a barn in Davidson County in it which is really cool. Things like that. Enhanced video production, and all of the design that went into making that happen. So, all of those things are in here so the raised budget that actually goes from \$36.1 million on up to \$37,673,703 is actually a result of outside money coming in

to help with this project and I just wanted to make sure that's clear and to thank the Downtown Transformation Board and the Team for their investment in our stadium.

I'd be happy to take any questions. [no questions]

2019-129 Creation of Opportunity Zones Task Force

City Council is requested to create an Opportunity Zones Task Force that will be appointed by the High Point Economic Development Corporation.

Mayor Pro Tem Ewing advised that while he was in attendance at the NLC Meeting in Washington, DC recently, he attended a number of meetings on Opportunity Zones. He explained that Opportunity Zones were created in the Tax Relief Package of 2017 and the final rules/guidelines should be coming out in about three weeks. He reported there are over 285 Opportunity Funds that have been created nationwide and these funds can be used to acquire property within the Opportunity Zones. Mayor Pro Tem Ewing shared that he has been working with the High Point Economic Development Corporation's staff over the past few weeks in strategizing as to how the city can best leverage what other cities are doing to try to realize more investment in High Point's Opportunity Zones which is in southwest High Point and the northwest part of Main Street. He stated in order to maximize the tax benefit, investments would need to be made in these properties by the end of this calendar year.

He noted many cities are creating an Opportunity Zones Task Force in an effort to be proactive in order to promote the Opportunity Zones.

Council Member Moore inquired about the composition of the Opportunity Zones Task Force. Mayor Pro Tem Ewing replied that it would be a mix of public and private sector

folks in certain professions that can actively try to promote the Opportunity Zones, as well as staff members, council liaison, etc.... The High Point Economic Development Corporation's staff will be responsible for appointing representatives to serve on the Task Force.

Mayor Pro Tem Ewing asked to be the Council liaison to the Opportunity Zones Task Force when the Task Force is formed and named. Mayor Wagner mentioned that there has been some discussion regarding switching a couple of liaison positions between Mayor Pro Tem Ewing and Council Member Jones and suggested they get with staff about the details so the changes could be placed on the April 15, 2019 City Council agenda for approval.
