May 6, 2019

Mayor Wagner opened up the floor for the Public Comment Period.

The following persons addressed the City Council during the Public Comment Period.

Beverly Bard, 2205 DeLaine Point, addressed Council regarding the following issues:

- 1. Ratification of the ERA (Equal Rights Amendment). She informed Council that the Greensboro City Council has affirmed agreement with the ratification and encouraged the High Point City Council to do so as well.
- 2. Education Voucher System. She expressed concerns that scholarships are given to students that attend charter/private schools and noted this money is not teturned to the tax base for public schools and they do not have to adhere to the same regulations. She asked that City Council reconsider the voucher program.
- 3. Need for sidewalks along Eastchester Drive at Festival Park.

Dorothy Darr, 501 W. High Avenue, Director of the Southwest Renewal Foundation, addressed Council regarding remaining 2012 Two-Thirds Bond money. She learned that there is about \$596,000 left in Two-thirds bond money that was designated for improvements to S. Main Street and a group of community activists has been meeting to discuss ideas on improvements to S. Main Street. She asked that the City Council continue this so they can meet with staff to share some of their ideas on how to utilize this money.

Mark Harris, 3212 Peninsula Drive, addressed Council on the following two items:

- 1. Remaining Two-Thirds Bond Money to work on improvements to S. Main Street to I-85.
- 2. Speeding issues on Hamilton Street behind the GTCC campus. He mentioned there have been many close calls where students were almost hit. He requested a study be conducted regarding the need for crosswalks at the lower portion before the hill on each side with a flashing light similar to the one that is in front of the GTCC campus on S. Main Street.

Susan Koger, 1902 Eastchester Drive, addressed Council regarding the following concerns about Eastchester Drive:

- ✓ Road construction
- ✓ speeding
- √ aggressiveness
- ✓ racing
- ✓ texting while driving

She suggested the following to help alleviate the concerns.

- ✓ More police presence
- ✓ posted signs
- ✓ Mobile speed indicator
- ✓ More stoplights at Rivermeade and top of hill at dental offices
- ✓ Lower speed in the Chik-fil-A and Applebees area
- ✓ Remove sign at bridge informing motorists of the metal plates in the road

Lawrence Cormier, 3007 Scout Trail, asked the City Council to reaffirm ratification of the ERA resolution and asked that Council at least give them the courtesy of an answer other than not being able to reach a consensus.

He also spoke about mental health issues.

Bradley Linnell, 236 Spencer Street, addressed Council regarding concerns with excessive speeding on Spencer Street.

Cyril Jefferson, 1448 Bailey Circle, addressed Council regarding the following two matters.

- 1. Downtown Development. He expressed appreciation to the City Council for the work they are doing with the downtown development and the excitement that is in the air with the stadium and the Coltrane House. He stated the proactive, cool mentoring and "can do" spirit provides tons of hope for residents of High Point.
- 2. Concerns regarding speeding on E. Grimes, Asheboro, Wise, and Park Streets.

Sara Sabanez, expressed concerns about the two lanes of traffic at the Intersection of Parris and Kirkwood and noted that many people do not even stop. She asked if this could be studied.

- 2) To refinance \$17.5 million in water and sewer revenue bonds issued in 2010 to a lower interest rate.

He noted a \$50,000 annual savings (\$500,000 over the life of the bonds) will be realized as a result of this action. The bonds will be issued subject to City Council authorizing application

to the Local Government Commission to issue the bonds and their approval thereof. The Local Government Commission is expected to approve the sale at their May 7th meeting.

2019-192 Ordinance to Demolish - 428 Ennis Street

City Council is requested to adopt an ordinance ordering the building inspector to effectuate the demolition of a structure located at 428 Ennis Street belonging to Shannon Tolbert.

Lori Loosemore, Local Codes Enforcement Manager, advised that a fire occurred on August 15, 2017 which prompted these proceedings. An inspection was conducted on September 25, 2017. A hearing was held on November 14, 2017 at which time it was determined that there were multiple violations of the minimum housing code in the house making it unsafe. The property owner did not appear for the hearing. In its present state, necessary repairs to the dwelling exceed 65% of the value of the structure. An Order to Repair or Demolish was issued on August 23, 2018 with a compliance date of September 27, 2018. Approximately \$647 in delinquent taxes are owed on the property.

Ms. Loosemore explained that the property owner did apply for a building permit, but has not called in for any inspections.

Chairman Golden asked if there was anyone present who would like to speak on behalf of this property.

Shannon Tolbert, owner of the property and a resident at 170 Walnut Grove Road in Lexington, NC, advised Council that he has been working on and helping another property owner to remodel several other properties in the area (337, 339, and 341 Ennis), but repairs to the structure he owns at 428 Ennis Street were stalled due to some hardships and financial hardships he encountered. He noted that he has cleaned the front of the property and removed the debris and has torn the roofing off and has purchased material to start framing it back. He asked Council for additional time (three to four months) so he could complete the repairs.

Council Member Peters asked Mr. Tolbert about his plans for the property. Mr. Tolbert replied that he plans on making the repairs and giving the home to his daughter.

Chairman Golden asked if the building permit was still active for 428 Ennis. Ms. Loosemore explained that once permits are issued, they are good for 12 months as long as long as the work has begun, but in this case no repairs have been made to the structure, so more than likely the permit has expired since it was issued in November 2017. Mr. Tolbert stated that he misunderstood what he was told otherwise he would have called in for a consult for some of the work that he did to clean up the property in order to keep it moving.

was told the permit would be good as long as calls are made for inspections and some progress is made. Council Member Ewing asked Mr. Tolbert if he is a licensed general contractor and Mr. Tolbert replied that he is not.

At this time, Council Member Golden moved adoption of the ordinance to demolish the structure. Mayor Pro Tem Ewing made a second to the motion.

For further discussion, Mayor Wagner stated his preference was to proceed with adoption of the ordinance and have staff monitor it.

Council Member Hudson advised Mr. Tolbert that he still has 30 days after adoption of the demolition ordinance in order to make the repairs. Mr. Tolbert indicated that he already has \$10,000 in the structure and did not want to put any more money into it if there is a possibility it might be demolished. He was encouraged to stay in contact with Ms. Loosemore to keep her updated as to what his plans are.

Mayor Wagner asked if there were any additional questions or comments. There being none, he called for a vote on the motion. The motion carried by a unanimous 8-0 vote as follows:

Lori Loosemore, Local Codes Enforcement Manager, reported that an inspection was conducted on the structure January 31, 2019 and several major violations were cited. A hearing was held on February 8, 2019, but no one appeared for the hearing. At that time, it was determined that the necessary repairs to the dwelling exceeded 65% of the value of the structure. 2019-203 Resolution - Pilot School Security and Safety Program

City Council is requested to approve a resolution supporting appropriation for a pilot school security and safety program, which would integrate security technology directly with Police and emergency responders, ensuring they have the best available information to respond in the event of emergencies at High Point schools.

Mayor Pro Tem Ewing reported this is an integrated system that would be installed within the city's schools and support for the resolution would enable the city to take the request to the Guilford County Delegation for them to make an appropriation for the system to be installed within public school systems in the High Point city limits as a pilot program for the County and State to create a safer school area for students. He pointed out this system has been implemented in a High Point Charter School, Phoenix Academy, and their systems are now integrated with the High Point 911 system and Police Department. He explained staff has worked closely with the IT people to ensure integration with the city's system and the new infrastructure and technology in the new 911 Center will be compatible, so it makes it a perfect pilot model within the school system. Mayor Wagner added that the system is the most technologically advanced school warning system anywhere. Mayor Pro Tem Ewing

reported that it is the first one in the United States that has been integrated with the municipalities 911 systems and agreed that it is truly cutting-edge technology that can be used to mitigate any potential disasters within our school systems. He noted that the City of High Point does not have much control over what happens in the schools because they are overseen by the Guilford County Board of Education, but if they are successful in getting this pilot program technology into the schools, it would be a big win for our school system.

Council Member Peters shared that as a mother of a sophomore at High Point Central High School, she felt it is very, very important for High Point to have this extra safety in our schools.
