PURPOSE:

To adopt a Resolution requesting the Guilford County Board of Commissioners to appoint a qualified representative to the High Point Planning & Zoning Commission to represent the Extraterritorial Zoning Jurisdiction (ETJ).

BACKGROUND:

John McKenzie is currently serving as the ETJ member on the High Point Planning & Zoning Commission. His term expired on July 1, 2019 and he no longer desires to serve in this capacity. N.C. General Statute 160A-362 provides for the manner in which ETJ members are appointed. Upon adoption of the Resolution by the High Point City Council, it will be forwarded to the Guilford County Commissioners for consideration. If they fail to make the ETJ appointment within 90 days after receiving a resolution from the city council requesting the appointment, the city council may then make the appointment.

John McKenzie is currently representing the City of High Point as the ETJ member on the Planning & Zoning Commission. His term expired on July 1, 2019. Mr. McKenzie no longer desires to serve in this capacity. Since this is an ETJ appointment, the Guilford County Commissioners is responsible for making the appointment.

The city of High Point respectfully requests a qualified representative be appointed to the High Point Planning & Zoning Commission to represent the extra-territorial zoning jurisdiction. The length of terms on this commission is three years. The city of High Point also respectfully requests that the appointment expire on July 1, 2022 to ensure that the terms remain staggered on the High Point Planning & Zoning Commission.

RESOLUTION REQUESTING THE GUILFORD COUNTY BOARD OF COMMISSIONERS TO APPOINT A QUALIFIED REPRESENTATIVE TO THE HIGH POINT PLANNING & ZONING COMMISSION TO REPRESENT THE EXTRATERRITORIAL ZONING JURISDICTION

- WHEREAS, the Guilford County Board of Commissioners has granted extraterritorial zoning jurisdiction to the City of High Point, and;
- WHEREAS, the General Statutes of North Carolina (G.S. 160A-362) require that such extraterritorial areas be represented with the membership of the Planning & Zoning Commission, and;
- WHEREAS, said statutes provide for the manner in which members of said Commission who represent an extraterritorial area are appointed, and;
- WHEREAS, said statutes state that if a board of county commissioners fails to make ETJ appointments within 90 days after receiving a resolution from the city council requesting that they be made, then the city council may make those appointments.
- WHEREAS, on July 14, 2016, the Guilford County Board of Commissioners appointed John McKenzie to serve as High Point's ETJ representative on the Planning & Zoning Commission, and;
- WHEREAS, Mr. McKenzie's term expired on July 1, 2019 and he no longer desires to serve in this capacity, and;
- WHEREAS, the appointment should be effective immediately upon appointment and should expire on July 1, 2022. This will ensure that the terms will remain staggered on the High Point Planning & Zoning Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HIGH POINT, NORTH CAROLINA that the Guilford County Board of Commissioners is requested to appoint a qualified representative to the High Point Planning & Zoning Commission to represent the extraterritorial zoning area.
