Steele Street is a predominantly longtime owner occupied residential street. We have always maintained our homes and looked out for one another. We have become an area caught in the cross-hairs of the growth of HPU and downtown, bordering English-Montliue and Main to Centennial. Which has now become a literal war zone where we fear for our safety and the safety of our family's and homes on a daily basis. Since Early September,2018 I personally have been robbed three times, and an attempted fourth. Three of my neighbors as well were robbed during the same time period. Steele street had two shootings in a five week period as well as shootings on Forrest and Denny streets. And Federal Marshall Apprehensions.

The past few years have become more challenging with the city's growth ramping up and moving forward. The city seems to have become more focused on the new growth and renovation and less concerned with the existing infrastructure. I understand all municipalities' run on budgets, but the first priority should always be the safety and well-being of the residents and visitors. I know High point has secured a loan to grow downtown yet it appears that none of that budget was dedicated to improving the surrounding area, specifically pertaining to the police department and code enforcement. It's clear that the city's policy's and priorities are outdated and ineffective. Having a qualified team enforcers both (police and Code) who have their hands tied and are unable to properly effect change is counterproductive.

Steele Street and the adjacent neighborhood is a trifecta it is less than half a mile from furniture market, HPU, the new ballpark and designated location for the children's museum. I have witnessed drug deals and prostitution on a daily basis from my own property, I have also been solicited for drugs and prostitution in what should be the safety of my own backyard.

Steele Street is a thriving part of market for both guest parking and showrooms. In October the 200 Steele building that just underwent an addition that was somewhere in the ballpark of 13 million dollars and had windows shot out. We have reached an all-time high for crime on our street, and the adjacent neighborhood. I fear the visitors this market will be subject to vandalism theft, or worse.

Two examples of residential addresses that have been completely abandoned and unmaintained for going on ten years. 501 Oakland Place has been abandoned and uninhabitable prior to 2008. It has sat and deteriorated for a decade and become a haven for criminals homeless, drugs, and prostitution and is adjacent to my backyard. 408 Steele Street has a similar history. I have personally called the city as well as the police regarding both for going on a decade and the results are nothing. All that happens are the owners are sent a notice and a fine is added to there tax bill which has resulted in no change in a decade. (completely ineffective)

I share in Mr Erwin's assessments, Concerns and solutions 100%. and would like to add that if the city does not take a zero tolerance proactive approach to gang violence, crime and lack luster property owners, the city will wind up with an empty ballpark, and excessive debt.

HIGH POINT, NC (WFMY) - A 14-year-old was one of two from High Point arrested Saturday for their suspected roles in a drive-by shooting where a 16-year-old was shot in the leg.

High Point Police found a 16-year-old had been shot in the leg on the 500 block of Steele Street around 3:15 p.m. Saturday. The teen was standing at the end of a driveway talking to two others when a green Mercedes drove by and fired five shots at them. The driver shot the 16-year-old in the left leg and the home behind them according to police. No other injuries were reported.

Around 6:25 p.m., an officer found the Mercedes involved in the shooting and started a traffic stop. The 14-year-old driver kept going before eventually crashing into a street sign at the intersection of Greer Avenue and Cloverdale Street. Both the 14-year-old and passenger Daniel L. Gelzer, 18, ran away before being arrested. Gelzer was tracked down by a K-9 team and the 14-year-old was arrested on scene.

The 14-year-old wasn't identified. He was charged with Felony Flee to Elude Arrest, three (3) counts of Felony Assault with a Deadly Weapon with the Intent to Kill, Felony Assault with a Deadly Weapon Inflicting Serious Injury, Discharging a Firearm in City Limits and Discharging a Firearm Into an Occupied Dwelling. He was taken to the Juvenile Detention Center in Greensboro.

According to the City of High Point, officers responded to 309 W. Fairfield Rd. in response to shots being fired at Sidelines Bar & Grill.

Officers located two people shot when they arrived on the scene.

There was also a large crowd when police arrived.

As officers attempted to access the victims, the hostile crowd interfered and additional units were needed to control the crowd.

To administer aid, Derrick Byers,34, had to be removed from the scene of the hostile crowd and driven across the street to a Walmart parking lot where he succumbed to his injuries.

The other victim, Quentin Brown,31, was taken to Moses Cone Hospital in Greensboro with multiple gunshot wounds.

Through early investigating, officers learned that a car involved in the shooting had been taken to a home on Gavin Drive in High Point.

After locating the car at the home, officers obtain an arrest warrant for Bobby L Wall Jr, 32, for 1st Degree Murder and Assault With A Deadly Weapon With The Intent To Kill Inflicting Serious Injury.

On Sunday, October 20, Wall was located and arrested by the United States Marshals Fugitive Task Force at a home in the 500 block of Richardson Avenue.

Wall is currently being held at the Guilford County Jail with no bond.
