PURPOSE:

City Council is asked to approve the purchase from Lawmen's Police and Tactical Supply to purchase pre-owned shotguns to include pistol grip, slim hard shell carrying case, sling, extended magazine tube, ghost ring night sights for the Police Department in amount of \$94,340.

BACKGROUND:

The High Point Police Department has a need for shotgun replacement. Lawmen's Police and Tactical Supply has offered the Police Department an opportunity to purchase pre-owned shotguns.

Lawmen's is allowing the High Point Police Department to trade in shot guns to realize significant savings. Currently equipment includes approximately 200 Remington 870 pump shotguns. They are in varying conditions and age ranges with some being over 20 years old. The trade in value for the newer Remington 870's (130 of these) is \$150.00 per gun for a total of \$19,500.00 of credit, our older model 870's (70 of these) will fetch a \$115.00 per gun for a total of \$8,050.00 for a grand total of \$27,550.00.

- At regular price: 255 x \$ 1,099.00 = \$280,245 \$27,550 (trade in credit) = \$252,695.00
- Lawmen's deal: 255 x \$478.00 = \$121,890 \$27,550 (trade in credit) = \$94,340.00

This is a savings of \$158,355.00 and upgrades all of our shotguns to a more modern platform.

BUDGET IMPACT:

Funding required for these shotguns was identified in salary savings and has been included in the current fiscal year budget for the Department.

RECOMMENDATION / ACTION REQUESTED:

The Police Department request Council approve the purchase of shotguns from Lawmen's Police and Tactical Supply in the amount of **\$94,340.00**.
