Subject: Code Enforcement Activity Report for February 2020

This report summarizes Code Enforcement activity for the month of February. During this period staff processed 35 new minimum housing complaints; 46 new public nuisance complaints and collected 161 signs. Additionally:

- Local Codes Enforcement Staff recorded 24 zoning complaints during the period.
- A total of 36 Public Nuisance cases were abated during the period (10 - City abated and 26 - owner abated).
- Inspectors didn't work on a Saturday during February but will resume in March.
- Demolition update:
 - 2 houses were demolished
 - 6 houses have contracts for demolition and should be completed by mid-March
 - 5 houses have demolition ordinances passed and will go out in 2 weeks for asbestos inspection, abatement and demolition bids
 - 4 houses are in process of being repaired after demolition ordinances were passed
- During the report period there were 576 total active cases:
 - 232 active minimum housing cases
 - 216 active public nuisance cases
 - 129 active zoning cases
