### **PURPOSE:**

City Council is asked to approve a Municipal Lease agreement with Motorola Solutions for WatchGuard 4RE/VISTA In-car camera / body-worn camera systems to be utilized by first responders for Information Technology Services and the High Point Police Department, in amount of \$1,380,436. These cameras are beneficial for not only capturing evidence of criminal acts, but also used for addressing citizen complaints.

### **BACKGROUND:**

The High Point Police Department currently utilizes Watchguard's in-car camera systems. We currently have 135 units in service. Most of these systems are no longer covered under warranty and approaching the end of their serviceable life expectancy. For the last two years the Police Department set up a budget line item for Watchguard system repairs for those units no longer covered under warranty. The repair line item was exhausted in April of this year two months before the end of the budget year. This is expected to continue happening as more units fall out of warranty. In Watchguard's current proposal, the City would realize a cost savings for an in-car system as well as a body camera system for the price of what the original in-car systems cost.

**BUDGET IMPACT:** The City of High Point would enter into the lease agreement on 6-26-2020 with the first least payment not coming due until fiscal year 2021-22 on 7-1-2021 and would be paid on an annual basis through 7-1-2024. The purchase is being made off of the NC State Contract 680D. The Police Department pledges to apply future Justice Assistance Grant (JAG) Awards toward the annual lease payment. Payments are as follows:
