BACKGROUND:

Information Technology Services is recommending the City of High Point purchase Audio Visual Equipment from Camcor Inc. for a purchase price of \$220,223.40. This purchase will provide all audio visual equipment for the new Police Department and 911 Center at 1730 Westchester Drive. This purchase will provide Audio Visual equipment for all conference rooms, training rooms, offices, 911 Center and public common areas.

BUDGET IMPACT:

The City of High Point will use existing funds in the FY 2020-21 budget to purchase the Audio Visual Equipment from Camcor, Inc. The total cost of the contract is \$220,223.40. This purchase will be made under the North Carolina State Purchasing Contract # 880. This purchase came in under the allotted budget of \$291,000 projected for the project.
