PURPOSE:

Pursuant to High Point City Ordinance Section $\frac{12 \cdot 2 \cdot 16}{11 \cdot 2 \cdot 16}$ 11-2-16 the owner of A+ Yellow Cab was served with Notice of Certificate of Public Convenience & Necessity Suspension due to documented violations of City ordinances and State laws. A hearing will be held on this matter before the High Point City Council during the August 3rd, 2020, regular meeting at 5:30 p.m. in the City Council Chambers. The Council will then decide whether to suspend, revoke, or reinstate the certificate.

BACKGROUND:

The decision to suspend the Certificate of Public Convenience & Necessity was based on the following documented violations of City ordinances and State laws.

- March 9, 2020: Operated a vehicle with a registration plate belonging to another vehicle in violation of N.C.G.S. 20-111 and C.O. 11-2-30
- April 8, 2020: Reduced minimum insurance coverage to well below City ordinance requirements in violation of N.C.G.S. 20-280 and C.O. 11-2-31
- June 26, 2020: Allowed an employee to operate a taxicab while subject to an impairing substance and while having an expired taxicab driver permit, in violation of C.O. 11-2-21
- July 4, 2020: Operated a vehicle with a registration plate belonging to another vehicle in violation of N.C.G.S. 20-111 and C.O. 11-2-30

Pursuant to High Point City Ordinance Section 12-2-16, this letter is to inform you that I, as Interim City Manager for the City of High Point, am suspending your certificate of public convenience and necessity for a period of thirty (30) days. You are not permitted to conduct taxicab operations during this time.

This decision is based on the following documented violations of City ordinances and State laws:

- March 9, 2020: Operated a vehicle with a registration plate belonging to another vehicle in violation of N.C.G.S. 20-111 and C.O. 11-2-30
- April 8, 2020: Reduced minimum insurance coverage to well below City ordinance requirements in violation of N.C.G.S. 20-280 and C.O. 11-2-31
- June 26, 2020: Allowed an employee to operate a taxicab while subject to an impairing substance and while having an expired taxicab driver permit, in violation of C.O. 11-2-21
- July 4, 2020: Operated a vehicle with a registration plate belonging to another vehicle in violation of N.C.G.S. 20-111 and C.O. 11-2-30

A hearing will be held on this matter before the High Point City Council during their August 3rd, 2020, regular meeting at 5:30 p.m. in the City Council Chambers. At that hearing, you will be able to offer evidence as to why your certificate should be reinstated. The Council will then decide whether to suspend, revoke, or reinstate your certificate.
