#### **BACKGROUND:**


After a site visit was made, this building at 2429 West Green Street was placarded as condemned due to failing construction. A notice was sent to the owner to attend the condemnation hearing. The determination after the hearing was to demolish the building.

#### **BUDGET IMPACT:**


\$35,000 Estimated plus asbestos removal if required.

#### **RECOMMENDATION / ACTION REQUESTED:**

Staff recommends the adoption of the requested ordinance to demolish this unsafe commercial structure, based upon the enclosed condemnation procedure.

Dear Owner,

A site visit was made to 2429 W Green Dr. High Point, NC 27260 at the request of the City of High Point Fire Marshals Office after discovering possible violations in the building. It was discovered that the building is especially dangerous life due to defective construction, decay, unsafe wiring, and other causes including water intrusion from the roof that covering has exceeded his lifespan. As a result of our inspection, this structure has been cited as defective and in a hazardous condition pursuant to NC General Statute 160A-426 and condemnation placards have been affixed to the rear portions building (former restaurant).

You are hereby notified to take immediate corrective action to safeguard the site by repairing or demolishing the structure. Please respond within ten (10) days of receipt of this letter with an immediate timeline for repair or demolition. If no reply has been received after ten days of receipt of this letter, the City of High Point Inspections Department will schedule a condemnation hearing to determine the best course of action in the interest of public safety.

An administrative hearing was held on February 17, 2021 at 10:30am at 211 S Hamilton St. High Point, NC 27260 concerning 2429 W Green Drive High Point, NC 27260.
