Councilwoman Peters: I would like to make a motion to suspend the rules to add this matter to the agenda.

Councilman Holmes: Second.

[Motion to suspend the rules to add matter to agenda passed unanimously 9-0 vote]

Mayor Wagner: Okay, I will turn the floor over floor over to Councilwoman Peters for discussion of the matter.

Councilwoman Peters: I would just like to add the Labonte Charity Ride to the list of city-sponsored events. The date is September 12th. The Finance Committee was able to have a wonderful presentation by Kristen Labonte. I would like to add it as a city-sponsored event.

Mayor Wagner: Is that a motion?

Councilwoman Peters: Yes, that's a motion.

Mayor Wagner: There's a motion to add that event to the list of the city's sponsored events. Is there a second.

Councilman Holmes: Second.

Wagner: It was seconded by Councilman Holmes. Is there any discussion.

Councilman Moore: I'd like to add that we, as a group, as we go forward, relook at the specific writing on our policy guidelines as to where they actually fit between Finance and the P & L. So, that can be clear as it can be going forward. I think there's been a little confusion going back and forth and it would be nice to eliminate that going forward.

Councilman Jones: Also, is Eric Olmedo around?

Assistant City Manager Eric Olmedo: Yes sir.

Councilman Jones: Did you ever figure out what a round figure is, not an exact number, but our hard cost to actually provide in-kind services?

Assistant City Manager Eric Olmedo: The round figure is about \$4,200. So, the original estimate that was placed before Prosperity & Livability was \$7,348, but when you take the, I guess, the amortized cost of the equipment, that's about \$398. That gets us to about \$4,196.

Councilman Jones: I just wanted to make sure that it's clear that anyone that's tuned in and listening to us is we're not agreeing to spend \$7,000, we're just not charging that. Our actual cost is a fraction of what they would have paid.

Councilman Hudson: I'll take exception to that because we do have to pay all the people that put the cones up. All the police, we pay. They're not working free. The city does pay their salaries while they're doing that work. Anybody that puts cones up from Parks & Rec, we're paying them to do that.

Councilman Jones: I agree with that, Wesley, 100%. That's why I wanted the actual hard cost. We're paying \$4,000, we're not paying the \$7,000, we're just paying the \$4,000 in-kind to sponsor an event for charity.

Councilwonman Peters: Well, actually it's not even paying \$4,100. I'm sure Eric can get us the exact number we would actually be paying for employees. But, anyway, I think it's a wonderful event for our city. I think what they bring here is amazing. We've got a Hall-of-Famer NASCAR racer who is wanting to give back to the community. They are their own non-profit that does not raise money for their own foundation. They have given \$50,000 to local charities. So, I am proud and honored to be in support of this event.

Mayor Wagner: Okay, is there anyone else who would like to discuss the motion?

Councilman Hudson: I would. This did go through the P & L Committee. It was discussed extensively with the P & L Committee and the P & L Committee unanimously decided to not sponsor this event and to put the Unity Festival in its place. Part of the discussion was we never actually sponsored the fund-raising bike ride, we sponsored the Cycling Classic and the purpose of the Cycling Classic was to bring people downtown to spend money and that's part of the purpose for the exemptions for the in-kind.

Councilman Holmes: Part of the reason that I think we agreed to remove that is that we were under the impression that it wasn't going to happen.

Councilman Hudson: It wasn't because it was the Cycling Classic. This Charity Ride has never....they've actually never applied to the city for a sponsorship.

Councilwoman Peters: Their application was just amended in February. The information that we were given was incorrect.

Mayor Wagner: Okay, I'm going to recognize Councilman Hudson. And then if others want to speak, speak up and I'll recognize you. We'll try to keep this organized as possible. So, the chair recognizes Councilman Hudson.

Councilman Hudson: Yes, the event was the Cycling Classic and the Cycling Classic was what was sponsored. They've never applied to the city to sponsor the Charity Ride. They applied to have the Charity Ride, but they've never applied for the city to sponsor the Charity Ride. The Charity Ride would go through the Finance Committee by definition since they are a non-profit, they would go through the Finance Committee. If they want to go through P & L, the purpose of P & L exemption is because it brings people downtown because it has economic impact and because it is something that all citizens can participate in. That's by definition what we do with the exemptions. If we want to consider it for next year, no problem considering it, but they haven't applied yet. They've taken the old event and they've added an event onto the old event and now they're not doing the old event anymore. They're still doing the add-on event under the auspice of the old event. So, they're not doing the Cycling Classic

which is what we sponsored. Now, they're doing a Charity Ride. They've just never applied for sponsorship. So, it's not that we're denying anything.

Councilwoman Peters: Mayor Wagner?

Mayor Wagner: Yes. You're recognized to speak.

Councilwoman Peters: I wasn't sure exactly where the confusion was, but it is an event for everyone in the community. It is a free community event with free food, free face painting, free jump houses. The only people that have to register, and that was.....the number of registered bikers for 2019 was 400. But that was just the registered bikers, that didn't include all those entire families that came out and enjoyed the children's activities and enjoyed all the other activities that they provided free.

Mayor Wagner: Is there anyone else who would like to be heard on the motion?

Mayor Pro Tem Williams: I have a couple of questions.

I've been told a few times that, excuse me because I'm just asking questions here. I've been told a couple of times that they take their donations and give to local charities. Has that been the situation every year with them?

Mayor Wagner: Yes, I do know that.

Mayor Pro Tem Williams: Okay. And that is not disputed, right?

Mayor Wagner: Not to my knowledge.

Mayor Pro Tem Williams: Okay. The other question I have and I know I'm kind of jumping out of the box on this one, but I want to know when we cancelled the Uncle Sam event, can they tell us the savings cost from that event. And, if we were to do this, because I figured if they do give to local charities which there are a lot of them that will definitely need assistance in the coming year, can we offset the cost of this event if we're looking at about \$50,000 for local charities, which will be a big help. Can

that offset what this potential in-kind service would be?

Mayor Wagner: I'll ask Mr. Olmedo for his opinion on that.

Assistant City Manager Eric Olmedo: Well, I don't have an opinion, but the insight that I have that we gathered from the list that we developed for the P & L Committee, the Uncle Sam Jam...and we only had police cost for the Uncle Sam Jam and it was about \$9,700. I know there's a number of costs that go on Parks & Rec, but they didn't itemize that. My guess is it would be well above that \$9,700.

Mayor Wagner: Was everybody able to hear his response? His response was the cost just in police alone is about \$9,700, but it does not include the Parks & Rec portion, so it could be a fair amount higher than the \$9,700. So, it would more than cover the cost of adding this cycling event.

Councilwoman Peters: Great.

Mayor Wagner: Is there anyone else?

Councilman Moore: Mayor Wagner?

Mayor Wagner: Yes, Councilman Moore.

Councilman Moore: Just a couple of points, back to my original point, I would urge all of us to, once we pass this budget, cycle to relook at these two. I think Councilman Hudson, who is chair of P & L, certainly has valid points, but I think there needs to be clarity on exactly the in-kind services versus what we try to do on the outside agency side and I would encourage us in this year, and I know last year, the Charity Ride donated quite a bit to local charities. But, they do pick the charities and I'd like to at least be able to think as a group of city leaders and staff we at least give them some recommendations of things that could help as well. And, per their consideration, as they make their decisions.

Mayor Wagner: Okay, I think that's something you can work on as committed chairs and have your committees work on it and bring something back to the full Council. So, I would just suggest that you get with Councilman Hudson and the two of you figure it out. And the Deputy

City Manager, Randy McCaslin, has nodded that's something they are working on.

Is there anyone else that would like to speak on the motion? Ms. Peters, I heard your voice. Do you want to speak again?

Councilwoman Peters: No, I just wanted to make sure that my motion was still on the table.

Mayor Wagner: It is. Okay, last chance for anyone who wants to speak before I call the vote roll.

Okay, Madam Clerk, are you ready.

City Clerk Lisa Vierling: Yes.

Mayor Wagner: Okay. The motion is to add the Labonte cycling event to our list of city-sponsored events for the coming year.

Councilman Holmes, how do you vote?

Councilman Holmes: Aye.

Mayor Wagner: Councilman Johnson?

Councilman Johnson: Aye.

Mayor Wagner: Councilwoman Peters?

Councilwoman Peters: Aye.

Mayor Wagner: Councilman Moore?
