Eric Olmedo, Assistant City Manager reported that under this year's 2020 Edward Byrne memorial Justice Assistance Grant (JAG), High Point would receive a total of \$49,297.60.
The HPPD would use the funding as pledged for a portion of the City's current Municipal Lease agreement of WatchGuard 4RE/VISTA In-car camera / body-worn camera systems with Motorola Solutions. Payments would be made over a five-year timeframe. The first payment would not be until FY 2021-2022 on July 1, 2021. Council was requested to adopt this resolution authorizing the execution of an Interlocal Agreement between the City of Greensboro,

City of High Point and County of Guilford for shared use of the JAG grant.

Sandy Dunbeck, Executive Vice President-High Point Economic Development extended recognized Vice Corporation greetings; Marshall Yandle, President-High Point Economic Development Corporation in attendance; and Loren President-High Point Economic Hill, Development Corporation participating remotely. Ms. Dunbeck made a PPP on Ariston Hospitality, Inc.; said that Platinum Collection Furniture, Inc of Alhambra, California, proposed to create 15 full-time jobs over the first two years with an average wage of \$37,147; would operate Ariston Hospitality Inc. at 1581 Prospect Avenue, High Point; would use the State of North Carolina Building Reuse Grant for this project with a local match of 5%; explained what the requirements were for the grant; and that the company would invest a total of \$1,527,000. The building is located in Randolph and Guilford county; and Randolph County had agreed to be the applicant for the project and would administer the grant. Ms. Dunbeck introduced Tony Tsai of Ariston Hospitality to speak on this matter.

Mr. Tsai extended greetings; shared a brief personal background; said he was a second generation for the furniture business; in 2006 he decided to supply commercial furniture; provided high-end contract furniture for hotels, senior living and hospital facilities; said he does a lot of business in Las Vegas; spoke to High Point's history with furniture; to being able to distribute on the east coast; provided a photo of what the building would look like after repairs, and renovations; said he would replace the existing roof; add new signs; a new HVAC system; new offices, and a showroom; thanked staff and council for the opportunity; and thanked the city of High Point for making him feel welcome.

Council Member Moore voiced appreciation for what Mr. Tsai accomplished; and said that he looked forward to taking action on this matter at the recessed

meeting of council.

#### **2020-454** North Carolina Department of Transportation (NCDOT) - Speed Limit Concurrences

City Council is requested to approve all concurring actions regarding speed limit ordinance updates for various routes throughout the city to ensure that the posted speed limit matches the most current ordinance for both the City and NCDOT.

> Mark McDonald, Director of Transportation; extended greetings; said this was part of an ongoing NCDOT review of speed limits on state-maintained roads. There are 25 concurrence actions, most of which are combinations of correlating repeals and enactments. All are administrative and did not change the existing speed limits. Several are associated with changes to the routing of US 70, which was shifting off the US 29 corridor and is being placed on W. Wendover Avenue through Greensboro and into High Point, and would then overlap with NC 68 (portions of Eastchester Drive, Westchester Drive, and English Road) to Thomasville. Only one action made a change to an existing speed limit. This occurs on a segment of Skeet Club Road that NCDOT posted at 40 miles per hour many years ago, when Skeet Club was still a two-lane road. The current widening project, which was nearing completion, expanded the roadway to four lanes with a median and had a design speed of 50 miles per hour. Typically, speed limits are posted at 5 mph below the design speed, and NCDOT proposed updating the speed limit on Skeet Club Road to 45 mph to be in conformance with this standard practice.

> Mayor Wagner noted that Business 85 designation would be illuminated; and become US 29; and moving Highway 70 to another route; and inquired on the timeframe for the signs referencing the changes to be installed. Mr. McDonald replied that the project would be completed within a year's timeframe.

Council Member Holmes asked if traffic lights would be installed in the Skeet Club area. Mr. McDonald replied yes; and that there were four new traffic signals included in the project. A motion was made by Council Member Hudson, seconded by Council Member Jefferson, that the ordinances be adopted. Michael McNair, Community Development Director reported that the city had partnered with Community Housing Solutions and Pinnacle bank to develop 19 affordable housing units in a subdivision under construction off Cedrow Drive. All of the homes in the Cedrow subdivision would be sold to income eligible families. Staff requested inclusion of the subdivision in the eligible area for the Core City Homebuyer Incentive. The Core City Homebuyer Incentive program had been in place since late 2015. It provided a down payment/closing cost incentive that encouraged homebuyers at all income levels to buy homes in the defined areas of the Core City. Council approved an extension of the eligible area to Spring Brook Meadows on 1/19/16. To date, 174 families had received down payment assistance through the program. There would be no budget impact, the program would utilize existing appropriated resources (federal); the Community Development and Housing Department is recommending the approval for modifications to the Core City Home-Buyer Incentive Program and that the appropriate City official and/or employee be authorized to execute all necessary documents.

Mayor Pro Tem Williams voiced appreciation to the Community Development Department, and the city for their efforts; spoke to home ownership having a generational impact; and said the program proved to be beneficial.

Council Member Moore inquired on the available funding left. Mr. McNair replied that an allocation of funding was done annually; said they budgeted on a regular basis; and acknowledged High Point University (HPU) for their support on this project.

Mayor Wagner echoed Mayor Pro Tem Williams' comments; spoke to the history of the program; said homeownership was important for stability in neighborhoods; and that he looked forward to continuing this program in the future.

Council Member Hudson reiterated Mayor Wagner's, and Mayor Pro Tem Williams' comments; and stated that this was how these types of projects were supposed to work.

Herb Shannon, Senior Planner-Planning and Development Department advised that he would be providing a combined presentation for Annexation 20-06, and Zoning Map Amendment 20-18; and that these two items would need to be voted on separately.

<u>Annexation 20-6</u>: The applicant requested annexation to have access to City utilities to facilitate development of an industrial use. This property was situated in the northern portion of the City's planning area, and is designated on the adopted Land Use Map for Restricted Industrial uses. There had been a number of annexation approvals to allow Restricted Industrial type uses in this portion of the City's Planning area since the 1990s. The site abuts the City's corporate limits along its eastern boundary and was adjacent to parcels that were within the City limits to the east, west and south. This annexation petition represented a logical progression of the City's corporate limits and City services and service vehicles were already present in this area. The annexation of this parcel would not negatively impact the City's ability to provide services in this area.

**Zoning Map Amendment 20-18**: A request by Robert J. Hunter to rezone approximately 6.8 acres from the Residential Single Family-40 (RS-40) District, within Guilford County's zoning jurisdiction, to the Employment Center (EC) District. The site is located along the south side of Tyner Road, approximately 1,300 feet east of Sandy Ridge Road (8229 Tyner Road). Approval of this rezoning request is contingent upon City Council approval of a voluntary annexation request. The Planning and Zoning Commission reviewed this request at their October 27, 2020 regular meeting and took final action when the meeting was reconvened on October 29, 2020; and recommended approval of the request as outlined in the staff report.

The applicant, Mr. Robert Hunter, was in attendance remotely but was unable to speak during the public hearing due to a technical problem with his microphone. Consistency and Reasonableness Statements

because the Land Use Map Plan and Northwest Area Plan designate the area of the proposed zoning map amendment as Restricted Industrial, which supports warehouse and distribution and minor manufacturing uses. Furthermore, the request is reasonable and in the public interest because the EC District's allowable uses, and its building and site design standards are similar and compatible with previous CU-LI conditional zoning approvals granted in this area.

Jeff Hunter (applicant) noted that he was a long-time resident of Kernersville; purchased said property 18 months ago; and that he was working with different companies for light assembly.

Council Member Holmes asked for clarification on the type of assembly Mr. Hunter did. Mr. Hunter replied that that he would be aligned with home improvement companies; and spoke to the demand for this type of business.
