PURPOSE:

Provide the Mayor and City Council an update on American Rescue Plan Act (ARPA) funding and review the application process for ARPA funding.

BACKGROUND:

The City of High Point received \$22,699,511 in American Rescue Plan Act (ARPA) funds in 2021. To date, the Mayor and City Council have approved \$16,852,085, leaving a remaining balance of \$5,847,426.

On February 6, 2023, the Mayor and City Council approved a community agency application process for ARPA funds, with a total funding amount to be determined at a later date.

Staff will be providing an overview of ARPA funding to date, as well the specifics regarding the community agency application process and timeline for ARPA funds.

There is no local budget impact. These are 100% federal funds.
