


HPFD Call Volume

Due to population increase in High Point, the demand on emergency services has dramatically risen. In the last 17 years, HPFD's call volume has risen from just under 11,000 calls to well over 16,000 calls. This amount of call volume is expected with an increase in citizenship. However, our operational personnel has only increased from 202 firefighters to 216.

With incidents covering everything from fires and medical responses to Hazmat and water operations, it is of the utmost importance that we keep our apparatus fully staffed with expertly trained personnel.

High Point Fire Department responds to medical emergencies ranging from heart attacks to minor scrapes and bruises. Responses also include vehicle accidents that may require patients to be extricated from entrapment.

HPFD Fire Prevention Division

Community Risk Reduction (Fire Investigation & Prevention Divisions) HPFD conducts fire investigations, code enforcement and fire life safety education programs to eliminate the threat of fire for the CoHP through the community risk reduction program. These programs are mandated by NC State Fire Code, relevant NFPA standards, Insurance Services Office (ISO), as well as HPFD general orders. The CoHP adopted the Fire Code in 1958, with the adoption being updated throughout various years. It was stated that future revisions are automatically adopted by reference.
